The MVSD will receive bid proposals for the Settling Basin 5 and 6 Demolition Project until one-thirty (1:30) o'clock P.M., Eastern Standard Time on Tuesday, September 23, 2025, via QuestCDN at which time Bids will be electronically opened and posted publicly.

To submit a vBid online bid (which is required for this project) you must download the project bid document file from QuestCDN, which will add you to the plan holders list and gain access to vBid Online Bidding.

The contractors are invited to attend the Bid Opening in person at the District located at 1181 Ohltown-McDonald Rd., Mineral Ridge, Ohio 44440. (MVSD will receive and accept bids ONLY through QuestCDN.com via their electronic VirtuBid™ online bid service at which time Bids will be electronically opened and posted publicly on QuestCDN immediately thereafter.)

The contract is for the Demolition of Settling Basins 5 and 6 and backfill with embankment material including topsoil and seeding & mulching. Prospective bidders are encouraged to schedule a site visit with the District to verify the site conditions.

Bids will be based on the specifications included in the contract documents and shall be made upon the blank form of proposal included in the contract documents. The form of proposal shall not be changed; each blank space provided therein for the entries shall be filled in; and each bidder shall furnish all information called for in the proposal and specifications.

A performance bond is required based on the total amount for which the Contract is awarded. Each bid shall be accompanied by either a bid bond or a certified check on a solvent bank in an amount not less than 10% of the amount of the base bid.

The Mahoning Valley Sanitary District reserves the right to reject any or all proposals, to waive irregularities in any proposal, and to award the contract as the best interests of the District may require.

The Bidders' attention is also called to the conditions of construction, and the wage rates required to be paid under this contract. The successful Bidder is required to pay at least the pre-determined minimum wage rates as set forth in the contract documents.

Each Bidder must ensure that all employees and applicants for employment are not discriminated against because of race, color, religion, sex, or national origin.

For the convenience of prospective bidders, a Pre-Bid Conference is scheduled for Wednesday September 10, 2025, at 10:00 A.M. at 1181 Ohltown-McDonald Rd., Mineral Ridge, Ohio 44440.
